Service Provided: Cats and Dogs that reside in households that meet eligibility requirements, will receive the following free services: 1 year rabies shot and Microchipping.

Eligibility: Pet owners must be able to provide proof of assistance from a PA Department of Health and Human Services program, such as SNAP, WIC or Public Housing Agencies such as HUD or Housing Choice Voucher. Pet's owners must be a resident of Westmoreland County. Up to three pets per households are eligible to participate.

2. Provide information for up to three pets (cats or dogs), that resides in the home. Services Requested boxes must be checked. One application per household.
3. Bring this signed application, photo ID and a copy of proof of eligibility with you to the Rabies Clinic.
4. Proof of eligibility can be a copy of an Access Card, in the applicant name or recently dated paperwork verifying eligibility for assistance. **ON THE COPY, BLACK OUT ANY INFORMATION OTHER THAN NAME AND/OR ADDRESS!** Do not include account numbers, case numbers, wage statements or social security numbers. Do not provide personal information beyond what is requested on the application.
5. You must bring your pets (cats in carriers and dogs on leash) to Lower Burrell Fire Co #3, 3255 Leechburg Road, between the hours of 10am-noon on April 22, 2017.
6. Make a copy of this application for your records Completed applications will be retained by Animal Protectors.
